## Pitty Rescue, Inc Policies for Dog Walkers/Volunteers

- 1. All equipment **MUST** be in new condition.
- 2. Walking tools (i.e. leashes, collars, etc) must be approved by Jeff Coltenback, founder, of Pitty Rescue, Inc
- Retractable leashes and devices are **NOT PERMITTED** for use when walking dogs owned and/or harbored by Pitty Rescue, Inc
- 4. You are volunteering at Pitty Rescue of your own free will. This is non-paid volunteer position.
- 5. When walking dogs owned and/or harbored by Pitty Rescue, Inc they are **NEVER** to be further than **6 feet** from you at any given time. NJ State Law requires dogs to be leashed in public using a leash no longer than **SIX FEET**!
- 6. Pitty Rescue dogs are **NEVER** allowed in dog parks. **NO EXCEPTIONS**
- 7. Pitty Rescue dogs are **NEVER** allowed off leash, ever. **NO EXCEPTIONS**
- 8. When walking dogs owned and/or harbored by Pitty Rescue, Inc they are **NEVER** to interact with the public or other animals without the supervision and approval of Jeff Coltenback. **NO EXCEPTIONS**.
- 9. All dog walkers are walking dogs **AT THEIR OWN RISK**. Pitty Rescue shall not be held liable for any damage or injury to anyone or their property. Each dog walker accepts FULL responsibility for the actions of the dogs they walk.
- 10. Pitty Rescue reserves the right to deny a dog walker to interact with or walk certain dogs.
- 11. Liability: Neither Pitty Rescue, Inc, nor any representative, heir, successor or affiliate shall be held responsible for any damages, costs or expenses incurred by the dog walker resulting from incidents occurring while walking Pitty Rescue dogs. This includes, but is not limited to, damage or injury to persons or property. In this regard, the dog walker holds harmless and releases this rescue and all representatives, heirs, successors and/or affiliates from any and all liability of any and every nature and accuse, directly and indirectly relating to the dog walker's walking dogs. - 13. You agree that you have valid and adequate health insurance in the event of injury. If you do not have health insurance, you hereby acknowledge that any medical care you may need as a result of walking and/or interacting with dogs owned and/or harbored by Pitty Rescue will be your responsibility and you will not seek litigation or compensation for medical care from Pitty Rescue or its heirs, successors or affiliates.
